3. Issue of Periodic Accounts to the Client

All Hydraulics & Estimating will prepare and issue a tax invoice at the end of each month. The Invoice will be for all works completed within that month. Any work carried over from end of month will be invoiced at the end of the following month.

4. Payment Conditions of Account

Payment conditions are **Strictly 14 days from Date of Invoice**. If payment is not received, by the Due Date, All Hydraulics & Estimating will issue a Statement. This issue of this Statement may incur a Late Payment Charge (Interest). Interest is calculated at a rate of **5%** per month calculated daily.

The Invoice payments can be paid in any one of the following ways:

- Direct Deposited to the All Hydraulics & Estimating's Bank Account nominated on all Tax Invoices and Statements.
- Credit card, fill in the remittance advice and return to All Hydraulics & Estimating's postal address.
- Mail Cheque to All Hydraulics & Estimating's postal address.
